- The "Prior Reading" column shows the beginning reading from the meter. Following a new meter installation, this will reflect either a "0" (zero) or a low number, which is the small amount of water used as crews test meters.
- The "Current Reading" column shows the water meter total at end of the billing period.
- The "Usage" column is generally calculated by subtracting "Prior Reading" from "Current Reading." Following a new meter installation, this column is calculated by adding the water used until a meter was changed out and any new meter usage thus far.
- Please note, sewer usage equals the same as your water usage.
- The Amounts are based on current Utility Service Rates (see rate sheet for details). There is always a base charge for service, even if your usage is at "0" (zero). **Please note, water rates increased by 7.5% in Fall 2023 due to increases from our wholesale water provider (the City of Rock Hill).**
- This is your billing date time period.
